



2023 Workers' Compensation Bills Labor Bills Dramatically Transform the WC Landscape





2023 Legislation

Vetoed

Mandatory Initial Hearings – A.6208/S.5867

Amends WCL §§ 20 & 25 to Require a Hearing on Every Indexed Claim

Vetoed - December 1, 2023

Requires a Hearing to be Held on Every Claim Within 60 Days of Indexing

- · Hearing Requests Must be Granted without limitations, prerequisites or penalties
- Hearings Must be Scheduled Within 45 Days of Request
- · Verbatim Reporters Required to Transcribe the Minutes of Every Hearing
- Minutes to be Provided at No Cost to Claimant in Their Native Language

Paid Family Leave Commission - A.4676-A/S.1554-B


Vetoed - November 17, 2023

Creates a Temporary Commission to Conduct a Comprehensive Study on the Current Utilization of Paid Family Leave

- 12 Governor Appointed Members of the Commission
- · Chair of the WCB serves as the chair of the Commission
- Produce a Report Within One Year of the Comprehensive Study
- Provide Recommendations on How to Remove Barriers to Use

Minimum Rate – A.2304-A/S.1161-A

Amends WCL§ 15(6) to Increase the Minimum Amount of Compensation

Signed - September 6, 2023

Increases the current minimum weekly rate from \$150 to not less than 1/5 of State Average Weekly Wage (SAWW)

- · Yearly indexes
- · Incremental increases for 2 years:
 - o \$275/week for DOA or disabilities starting 1/1/2024, \$325/week for DOA or disabilities between 1/1/2025 and 7/1/2026, starting 7/1/2026 indexed to 1/5th of SAWW
 - o Impact of minimum rate includes all disabilities- PPD, TPD, PTD, and TTD
- Employee receives full wages if equal to or less than 1/5 of SAWW

Expansion of Language Access-A.5609/S.6096

Amended WCL § 17-a to Increase the Provision of Language Access Services

Signed - September 15, 2023

All Vital Documents and WCB Forms That Provide Information to Injured Workers Regarding Filing for Workers' Compensation Benefits Shall be Translated Subject to Executive Law 202-A

- Vital Documents and WCB Forms Must be Translated into 12-16 Languages vs. 10
- WCB Required to Hire Language Access Coordinator (Hired Prior to Bill)
- WCB Required to Develop and Publish a Language Access Plan

Public Group Trust – A.52-B/S.6410-A

Amended WCL § 50 to Authorize Certain Groups to Self-Insure as a Group

Signed - September 15, 2023

Sets Forth the Criteria and Regulatory Oversight for Public Group Self-Insurers

- Deductible Options Regulated by WCB
- · Imposes Additional Restrictions on Offering Deductible Programs
- Mitigates Risk of Insolvency

Major Reform Revisited

Pharmacy Choice - A1219/S.1974


- Amends WCL § 13
- Removes Requirement to Use Contracted Network Pharmacy

Permanent Total Disability - A.391/S.1799

- Amends WCL § 15 to Add Additional Definitions to PTD
- Imputes SSD Findings on the WCB

Extreme Hardship - A.294/S.1798

- Amends WCL § 35(3)
- Reduces "Extreme Hardship" threshold from LWEC of 75% to LWEC of 50%
