## NYSIA JANUARY 2025 ANNUAL MEETING SPEAKERS



**Robert Duarte, MD** is the Director of the Pain Management team at Northwell Neurology Neuroscience Department. He is also the Associate Professor of Neurology at Zucker Hofstra School of Medicine. Dr. Duarte is a founding member of the Northwell Concussion Center and continues to be the primary Neurologist assessing and treating post concussion conditions. He has written chapters and lectured extensively on the role of the neurologist in traumatic brain injury, headache and chronic pain. Dr. Duarte is a sideline physician for higher school football teams in Queens and Long Island. He served as Captain and Surgeon General of the New York State Guard 2017-2023 and was the President of the New York State Pain Society from 2016-2018.

He performs IME examinations for neurological conditions including pain, headache and traumatic brain conditions.
