## NYSIA JUNE 2025 SPRING WORKSHOP SPEAKERS

Dr. Nicholas Tolchin earned a Bachelor's degree in Biology and a Minor in Psychology from California Polytechnic State University, San Luis Obispo, in 1999. He then went on to earn a PhD in Clinical Psychology, with a specialization in Neuropsychology, from the California School of Professional Psychology, Fresno Campus, in 2007. In the early stages of his career, Dr. Tolchin concentrated on providing forensic and neuropsychological treatment in correctional facilities across New York and New Jersey. He also gained valuable experience in skilled nursing and rehabilitation settings, offering neuropsychological and mental health treatment. In 2012, Dr. Tolchin transitioned to more specialized forensic work, initially conducting psychological evaluations for individuals applying for Social Security disability benefits. He then expanded his expertise to include parental fitness evaluations for the New Jersey family court system. By 2017, Dr. Tolchin began conducting forensic psychological and neuropsychological evaluations, as well as providing psychotherapy, primarily for Worker's Compensation insurance referrals, with a focus on trauma and traumatic brain injury cases. In 2021, Dr. Tolchin began conducting independent medical evaluations (IMEs), specializing in both psychological and neuropsychological assessments. The following year, Dr. Tolchin took on the role of Clinical Manager at Work Comp Psych Net, overseeing the quality assurance of psychological evaluations conducted by licensed consultants. He also provided case consultation and supervision for these professionals. In early 2024, Dr. Tolchin was appointed as the Clinical Director of WCPN, a PAX Health Company, where he continues to lead and shape the clinical direction of the organization.
